MAKE A NOTE!

Drug Hotline	510-238-3784	Drug house, suspected drug house, drug dealing, suspected drug dealing
Prostitution Hotline	510-777-3333	This is a voice-mail that the OPD checks and tracks daily. Describe the prostitute's attire, hair, height, weight, anyone with her, any male, any cars that stop, location, time
Alcohol Beverage Action Team	510-238-7103	Liquor store: harassment of customers, loitering, illegal activity outside of store, sale to minors, after hours sales, sales of mixed drinks, trash or blight connected to store
Code Enforcement	510-238-3381	Blighted Buildings: collapsing roof, wall or fence, broken windows. Note activity in/around vacant buildings and other dangerous conditions such as trespassers.
Code Enforcement	510-238-3381	Blighted Yards: Describe the kind of trash, overgrowth, cars, junk, and amount of time the blight has existed.
Hotel/Motel Nuisance		For drug sales or use call 238-3784. For prostitution or other illegal activity call 777-3333. For blight or hazards around the building or if it's being used as long-term housing, call 238-3381
Illegal Dumping	510-434-5101	On public property- describe contents and amount of the dumping, the nearest address where it's been dumped and by whom
Litter Enforcement		Any business, individual, development, or vehicle that does not put trash/litter in a proper receptacle.
Toxic Polluters, Hazardous Waste	510-444-1616	Identify quantity involved, packaging and/or markings, and color of materials. Look for discarded oil, paint, used batteries, anti-freeze, etc Record the location and amount of these materials.
